### Artikel 1: Introduction

## Article 6: Data retention period and inspection

When your customer relationship with me ends, I store some data on the basis of the statutory retention period. I delete data that is no longer needed. After the statutory retention period, I destroy all data. You have the right to inspect the data I have about you. You can submit a request for inspection, correction or deletion to PetzCare by e-mail. To ensure that the request for access has been made by you, I ask you to send a copy of your identity document with the request. To protect your privacy, I hereby ask you to blacken your passport photo and citizen service number (BSN). Your request will be processed within the statutory period.

## Article 7: Sharing with others

PetzCare only provides your data to third parties (such as a veterinarian) if this is necessary for the execution of our agreement with you, or to comply with a legal obligation.

## Article 8: Telephone conversations

Phone calls are not recorded and saved.
